### Reabertura dos Shoppings Centers da Aliansce Sonae

**Rio de Janeiro, 15 de junho de 2020 - A Aliansce Sonae Shopping Centers S.A** (“Aliansce Sonae” ou “Companhia”) (B3: ALSO3) vem informar aos seus acionistas e ao mercado em geral, em complemento ao fato relevante divulgado em 11 de junho de 2020, que as operações nos seguintes shopping centers foram retomadas: (i) Shopping Metr pole, nesta data; (ii) Shopping Tabo o, nesta data e (iii) Caxias Shopping desde 13 de junho de 2020. Os Shoppings est o funcionando em hor rio reduzido e seguem r gido protocolo de reabertura, que visa preservar a sa de e o bem-estar de todos os clientes, lojistas, colaboradores e parceiros. As opera es nos segmentos de alimenta o e entretenimento seguem as restri es impostas pelas autoridades locais. Atualmente, vinte e um Shoppings do portf lio pr prio da Companhia j  voltaram a operar, o que corresponde a 76% do total de NOI e 73% da ABL pr pria.

Os demais ativos da Companhia, seguem funcionando apenas com servi os essenciais e as atividades de delivery e Drive-Thru & Pick-up.

### Reopening of Aliansce Sonae Shopping Malls

**Rio de Janeiro, June 15<sup>th</sup>, 2020 - Aliansce Sonae Shopping Centers S.A.** (“Aliansce Sonae” or “Company”) (B3: ALSO3) hereby announces to its shareholders and to the market in general, in addition to the material fact disclosed on June 11<sup>th</sup>, 2020, that the operations of the following shopping malls were reopened: (i) Shopping Metr pole, today; (ii) Shopping Tabo o, today and (iii) Caxias Shopping, since June 13<sup>th</sup>, 2020. The centers are operating with reduced hours, in compliance with a strict reopening protocol to preserve the health and wellness of all clients, tenants, employees and business partners. Food and entertainment operations follow restrictions imposed by local authorities. Currently, twenty one owned assets in the Company's portfolio have already resumed their operations, corresponding to 76% of the total NOI and 73% of the owned GLA.

The remainder assets of the Company are still operating with essential services, delivery and drive-thru & pick-up activities.
